MEMBERSHIP OPTIONS

All Memberships are subject to a monthly account minimum food/beverage charge requirement; all food and beverage purchases in the 19th Hole Bar & Grill, Pro-Shop, and the Event Center are applied against the minimum. All membership and add-on fees are subject to Texas Sales Tax of 8.25%.

VIP Family/Full

Includes all privileges of the club: use of golf, tennis, and clubhouse facilities for each individual in the member's immediate family: (e.g., member, spouse, and children under the age of 18). This membership is non-transferable. Food Beverage Minimum \$60.

Couple Membership

Includes all privileges of the club: use of golf, tennis, and clubhouse facilities for a couple. This membership is non-transferable. Food Beverage Minimum \$50.

- INITIATION FEE \$ 500
 - MONTHLY DUES \$ 250

Single Membership

Includes all privileges of the club: use of golf, tennis, and clubhouse facilities for one individual. This membership is non-transferable. Food Beverage Minimum \$30.

- INITIATION FEE \$ 300

Junior Membership

Includes all green fees for an individual who is between the ages of 13 and 20. Junior members must convert their membership to a full membership within five years of becoming a junior member (or by age 20, whichever comes first) by paying applicable difference between their original payment to the club at the time of initial acceptance, and then prevailing initiation fee of full membership. This membership is non-transferable.

Social Membership

This is a non-golf membership including the use of the tennis courts, and other clubhouse facilities. This Membership is non-transferable. Food Beverage Minimum \$25.

Winter Texan Membership (No Initiation Fee or Food/Beverage Minimum applies)

This is a seasonal membership for players residing outside of a 75-mile radius of the Lakeside Golf Club. This membership is nontransferable and is intended to last 3 to 4 months per year (may not exceed 6 months per year).

The designee may be changed within the corporation or firm subject to approval and payment of the requisite transfer fee. This membership is non-transferable.

Authorization for Payment of Fees - Electronic Bank Draft or Credit/Debit Card

I authorize Lakeside Golf Club and the financial institution or credit card company named above to deduct the amount of my monthly fee from the account identified above. I understand my automatic payment will be deducted on the first day of each month. Changes in bank account or credit card information must be submitted by completing a new Membership application form and filling out the payment information section. Changes must be received by the last day of the month in order to be processed for next month's payment. Cancelling a bank draft or credit card does not cancel a membership. In the event that a bank draft is revoked, or an account is closed, and new bank or credit card information is not received, the membership fee can be paid by check. Account balances due to the Club shall be payable no later than 30 days following the statement date. If any payment is not received within 90 days of the due date, the applicant hereby authorizes the Club to charge the amount due, plus any applicable fees or penalties, to the credit card listed on the account. Early termination will only be accepted in the event of a member who passes away or a member who has accepted a military assignment out of the area.

I agree to abide by all rules, regulations and bylaws of Lakeside Golf Club, Inc. I understand and agree that this membership will begin on the date that this Contract is signed and will run continuously, renewing on a monthly basis, until a written and signed cancellation is submitted by the Member or notice of cancellation is mailed by Lakeside Golf Club, Inc. I understand that this membership will automatically renew for all subsequent months unless cancelled pursuant to this agreement. I also understand that management reserves the right to increase the fees for subsequent membership terms by notifying me in writing 30 days prior to the start of the new membership term at my last known address or email. I further understand that the initiation fee is a non-transferable, non-refundable fee. I understand that in the event of a default of this Membership Agreement by the Member, Lakeside Golf Club, Inc shall have the option to revoke my membership and all rights and privileges of Lakeside Golf Club, Inc with no refund of any amount previously paid. Member hereby agrees that no formal notice of default shall be required even if the nature of the default relates to failure to pay monthly dues, fees, charges, or any violation of Lakeside Golf Club, Inc rules and regulations.

Memberships may be cancelled by the member by submitting a formal request of cancellation/resignation and will be honored under the following terms: The form is completed and **received** a minimum of 30 days prior to requested cancellation date. If a membership is cancelled and a renewal of the membership requested within the same calendar year, Lakeside Golf Club, Inc reserves the right to initiate a review of the new membership, decline it, or, in case of approval, member understands a new initiation fee will apply. Lakeside Golf Club, Inc, may at any time cancel, modify or change any membership costs and/or privileges upon written 30-day notice mailed to the last known address of the member. Any notice sent by Lakeside Golf Club, Inc is calculated from the earlier of the date the notice is mailed or received in-person.

Waiver/Release

I hereby agree to participate and/or engage in the use of the course, equipment, facilities and programs offered by the Club upon the understanding and agreement that:

1. I am aware of the risks of illness or injury inherent in any golf or exercise activity. These injury risks include but are not limited to: being hit by golf balls, golf clubs, golf carts, or lightning; stepping or tripping in holes or other natural indentations in the ground; injury from insects, animals, birds or snakes, drowning; pulled muscles or other sprains, strains or injuries. I am participating in the Club’s programs upon the express understanding that I hereby indemnify, defend, waive and release the Club, its employees, agents, officers, Directors, Successors, and Assigns from any and all claims, costs, liabilities, expenses or judgments, including attorney’s fees and court costs (hereafter referred to as the “Claims”) arising out of my participation and the participation of my family and guests in the program(s) or any illness or injury resulting there from, and hereby agree to indemnify and hold harmless the Club from and against any and all such Claims defend, indemnify and hold harmless.
2. Lakeside Golf Club, Inc golf course and facilities will be maintained to allow for normal golf activities. There is no guarantee as to the condition of the course or any amenity included in this membership. Members will have access to amenities listed in this agreement subject to availability, which is to be determined at the sole discretion of Lakeside Golf Club, Inc. Certain private and public events may dictate that the golf course, practice areas, restaurant and/or other areas of Lakeside Golf Club, Inc be closed. Member understands and agrees that nothing in this Membership Agreement shall entitle member to any of the facilities on any particular day nor to any discount or refund on account of any limited access. Member further understands that access to the course, practice facility and the restaurant and other privileges and benefits may be limited by Lakeside Golf Club, Inc as necessary. No member is entitled to a refund or return of amounts due to damage to or condition of the golf course or any amenity. Further, Lakeside Golf Club, Inc shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions or any and all other matters beyond control of Lakeside Golf Club, Inc.

Miscellaneous Provisions

Entire Agreement: This Membership Agreement constitutes the full and entire Agreement between the Parties hereto and such Parties acknowledge that there is no other Agreement, oral and/or written, between the Parties hereto.

Severability. Should any term, provision, covenant and/or condition of this Membership, or any clause of part thereof, be held by a court of competent jurisdiction to be invalid, illegal, void or unenforceable, it shall be deleted from this Membership Agreement, and the balance of the Membership Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated. Assignment: The member’s rights, privileges or interests under this Membership Agreement are not assignable or transferable. However, Lakeside Golf Club, Inc may assign its interest in this Membership Agreement, and the liability of the assignor shall be terminated as to events occurring after assignment.

Modifications: This Membership Agreement may be amended or modified only by a writing signed by the Member and the golf course manager.

Counterparts: This Membership Agreement may be executed in counterparts with the same effect as if all original signatures were placed on one document and all of which together shall be one and the same Agreement.
